| Any mode, including multimodal | EXW – Ex Works (…named place) | Have goods ready when promised and export packed to the extent the shipping particulars are made known. | Everything else (pre-carriage, export clearance, main-carriage, import clearance, on-carriage) |
| Any mode, including multimodal | FCA – Free Carrier (named place) | Have goods ready when promised and export packed to the extent the shipping particulars are made known. If carrier picks up, load collecting conveyance. Otherwise, deliver to designated place without unloading. Arrange export clearance. | Pre-carriage (unless place is carrier's terminal), main-carriage, import clearance, on-carriage |
| Sea and Inland Waterway | FAS – Free Alongside Ship (named port of shipment) | Deliver the goods, appropriately export packed, alongside the vessel designated by the buyer at the port designated by the buyer. Arrange export clearance. Seller is responsible for terminal handling, but <u>not</u> vessel loading. | Vessel loading, main-carriage, import clearance, on-carriage |
| Sea and Inland Waterway | FOB – Free on Board (named port of shipment) | Deliver the goods, appropriately export packed, past the rail of the vessel designated by the buyer at the port designated by the buyer. Arrange export clearance. | Main-carriage, import clearance, on- carriage |
| Sea and Inland Waterway | CFR – Cost and Freight (named port of destination) | Deliver the goods appropriately export packed, on board the vessel, and pay all transport costs to the point of destination. Arrange export clearance. (Seller responsibility ends on the seller's side) | Unloading, import clearance, on-carriage |
| Sea and Inland Waterway | CIF – Cost, Insurance and Freight (named port of destination) | Deliver the goods, appropriately export packed, on board the vessel, and pay all transport costs to the port of destination. Purchase at least minimum cover marine cargo insurance. Arrange export clearance. | Unloading, import clearance, on-carriage |

| Any mode, including multimodal | CIP – Carriage and Insurance Paid To (named place of destination) | Deliver the goods, appropriately export packed, to the carrier to transport the goods to the named place of destination by a usual route and in a customary manner, and pay all transport costs to the place of destination. Purchase at least minimum cover marine cargo insurance. Arrange export clearance. | Import clearance, on-carriage if the place of destination is an arrival point (airport, seaport) |
| Any mode, including multimodal | DPU – Delivered at Place Unloaded (named place of destination) | Arrange for export clearance, deliver the goods appropriately packaged at the named destination and pay all transport costs <u>including</u> unloading. | Import clearance and on-carriage |
| Any mode, including multimodal | DAP – Delivered at Place (named place of destination) | Responsible for export clearance, delivery of goods appropriately packaged to named destination and all transport costs thereto. | Responsible for unloading, import clearance and on carriage. |
| Any mode, including multimodal | DDP – Delivered Duty Paid (named port of destination) | Deliver the goods, appropriately export packed, to the named place of destination, and pay all costs involved in getting them there. Arrange export clearance and import clearance. | On-carriage if the named place is an arrival point (airport or seaport). |
